ASPI EUROZONE® INDEX CONSTITUENTS: QUARTERLY REVIEW

The ASPI Eurozone® index selects the 120 best rated companies in the Eurozone on the basis of VIGEO's CSR ratings.

The ASPI Committee proceeded to the quarterly review of the Index components.

Preliminary

At the review date, 120 companies were included in the index.

IRISH LIFE & PERMANENT (IE) will be withdrawn from the Dow Jones Euro STOXXSM index on 19 June 2009 at the quarterly review of the index. Therefore, it will be withdrawn from the ASPI Eurozone® on the same day.

The company TUI (DE) having being rated "--" in one of Vigeo's analysis domains, it will be removed from the ASPI Eurozone® at the quarterly review in accordance with the ASPI Eurozone® Guidelines.

Additions: 2 constituents

In order to maintain a total number of 120 constituents, the shares of the following companies have subsequently been selected to enter the ASPI Eurozone® index on the basis of their VIGEO ratings: BAM GRP (NL) and SOLVAY (BE).
