**ASPI EUROZONE® INDEX COMPONENTS:
ANNUAL REVIEW**

The ASPI Eurozone® index selects the 120 best rated companies in the Eurozone on the basis of VIGEO's CSR ratings and in accordance with the ASPI Eurozone® Guidelines.

On September 3rd 2009, the ASPI Committee has carried out the annual review of the Index constituents.

Preliminary

At the review date, 120 companies were included in the index.

Additions: 6 components

At each annual review, the ASPI Committee adds in the ASPI Eurozone® index the shares of companies included in the Dow Jones Euro STOXXSM index that are among the 100 best rated companies by VIGEO. Accordingly, the following companies are added to the index: **ADP** (FR), **SNAM RETE GAS** (IT), **TERNA** (IT), **BOLSAS Y MERCADOS ESPANOLES** (ES), **NESTE OIL** (FI) et **SOLARWORLD** (DE).

Withdrawals: 6 components

The shares of the following companies are subsequently withdrawn from the ASPI Eurozone® index on the basis of their VIGEO ratings in order to obtain a total number of components of 120: **EIFFAGE** (FR), **AHOLD** (NL), **BANKINTER** (ES), **INFINEON TECHNOLOGIES** (NL), **SANOMA** (FI) et **LAGARDERE** (FR).
