**ASPI EUROZONE® INDEX COMPONENTS:  
QUARTERLY REVIEW**

The ASPI Eurozone® index selects the 120 best rated companies in the Eurozone on the basis of VIGEO's CSR ratings and in accordance with the ASPI Eurozone® Guidelines.

On 2 June 2010, the ASPI Committee has carried out the quarterly review of the Index constituents.

**Preliminary**

At the review date, 120 companies were included in the index.

BAM GROUP (NL) will be withdrawn from the benchmark index Euro STOXX<sup>SM</sup> on 21 June 2010 for the quarterly review of the index. Therefore, it will be withdrawn from the ASPI Eurozone® the same day.

The companies FRESENIUS MEDICAL CARE (DE) and SOLARWORLD (DE) having being rated "--" in one of the 6 Vigeo's analysis domains and in accordance with the ASPI Eurozone® Guidelines, they will be removed from the ASPI Eurozone® for the quarterly review.
